CHILDREN'S RIGHTS PROTECTION POLICY

= a set of principles, rules and measures aimed at protecting children's rights

INTENTIONS:

- ensure children's safety
- support child development
- respect children's voices
- ensure equal opportunities

INAPPROPRIATE TREATMENT OF CHILDREN

FORMS

- physical violence (beating, burns, suffocation,...)
- psychological violence (verbal abuse, humiliation, making fear,...)
- sexual violence (inappropriate physical contact, pornography, exhibitionism and watching the sexual activities of others)
- exploitation of children for profit

IMPLEMENTATION


- > PREVENTION**
 - all programs and activities must be safe
 - risk analysis is carried out for new programs
- > MONITORING**
 - the responsible person regularly monitors and evaluates the implementation of the policy
 - surveys among employees and volunteers on compliance with standards
 - in case of violation - reactive evaluation and possible policy adjustments
- > REPORTING**
 - the responsible person ensures: informing employees about the policy
 - documentation, investigation and resolution of violations
